1. Flagship Farms Cash Rebate Checks will run from September 1 to August 31<sup>st</sup> of each year starting with 2026 growing season. These Cash rebate checks will be on qualifying products and are subject to change each year.
2. Cash Rebate Checks will be paid out by the end of the year for the qualifying year pending accounts are paid in full for Receivables and Golden Advantage.
3. To qualify for rebate category will be off of total farm dollars spent with Farmers Choice not qualifying products.
  - Bronze spend 100,000 to 250,000
  - Silver spend 251,000 to 400,000
  - Gold spend 401,000 to 650,000
  - Platinum spend 651,000+
4. All invoices are to be paid "Net 15<sup>th</sup> of the following month" unless other terms are agreed upon by the owner and the customer.
5. Accounts extended beyond due date will accrue a fee equal to 1.5% (18% APR, \$5.00 min) of the unpaid balance back to the invoice date per month.
6. If an account exceeds 60 days past due, interest will carry 2.5% per month of 30% APR.
7. Invoices past 90 days from invoice date are subject to a supplier's lien with the state of business.
8. Claims arising from invoices must be made within seven working days.
9. The undersigned agrees to pay all amounts due plus any collection costs and attorney fees incurred.
